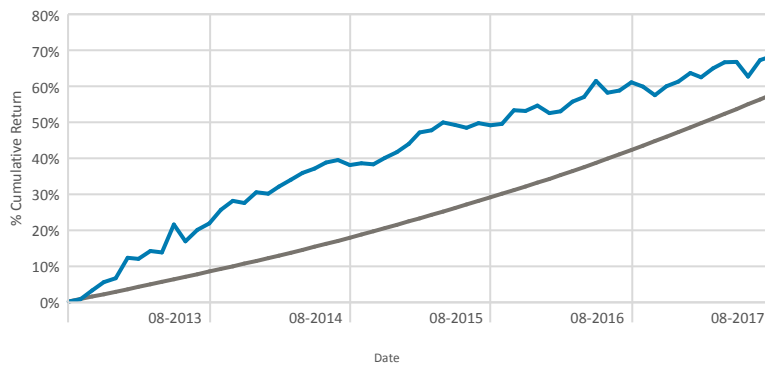
## INVESTMENT OBJECTIVE

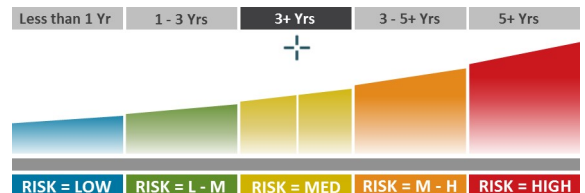
