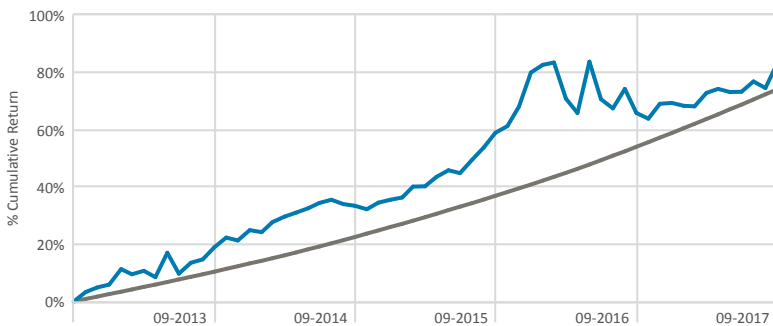
INVESTMENT OBJECTIVE

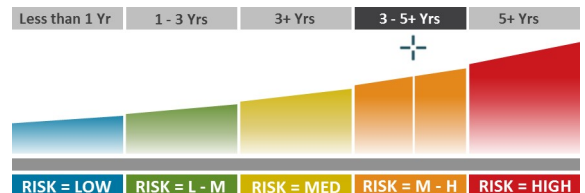
