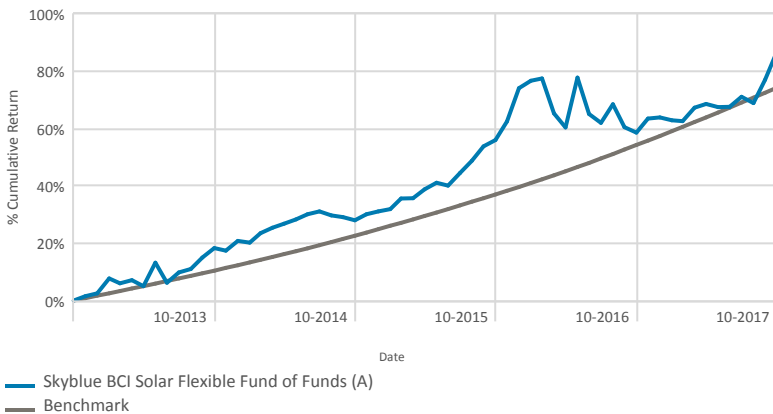
INVESTMENT OBJECTIVE

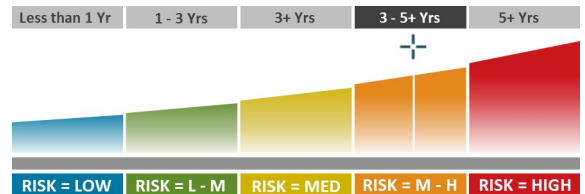

Medium - High Risk
