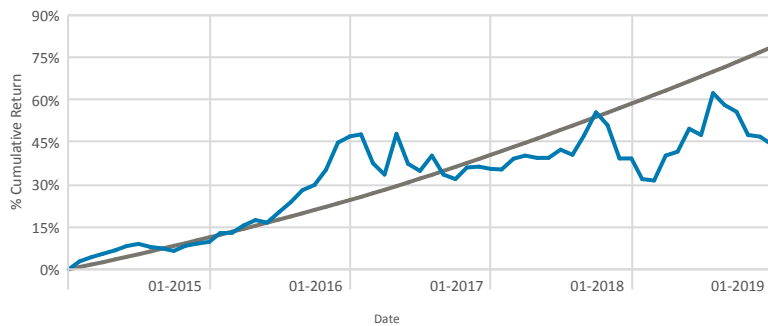
## INVESTMENT OBJECTIVE

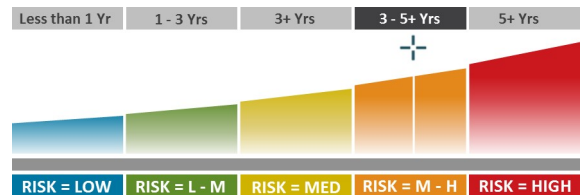

### Medium - High Risk
