



+ INVESTMENT OBJECTIVE

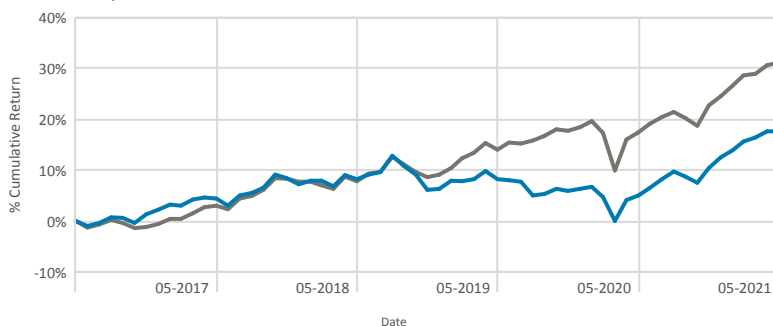
The primary investment objective of the portfolio is to provide the investor with a high level of capital stability over the medium term.

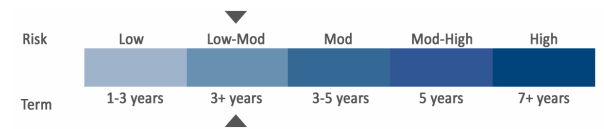
