



+ INVESTMENT OBJECTIVE

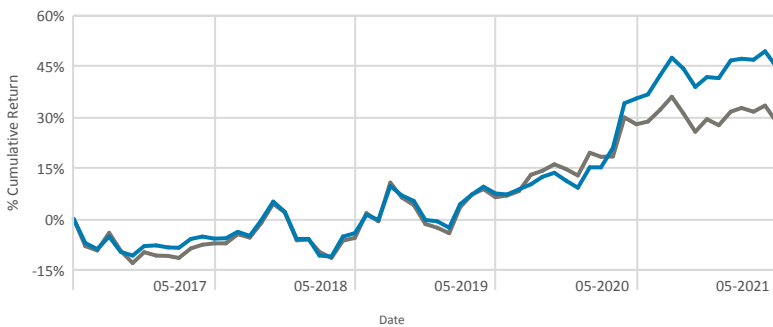
The investment objective of the portfolio is to maximize long term total returns whilst providing investors with above-average medium to long term total return.

The portfolio may from time to time invest in listed and unlisted financial instruments. The manager may include forward currency, interest rate and exchange rate swap transactions. The portfolio manager is managing the portfolio with a 80% minimum offshore exposure.

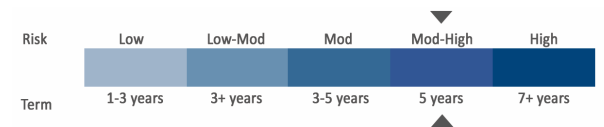
